



Terms and Conditions

Paragraph 1: The Event

The European Vespisti Week 2025 will take place in Novi Sad, Serbia, from June 12th to June 15th, 2025, with a limit of 2,000 participants, with an option for expansion up to 3,000 participants.

The Vespa Village will be located at: Bulevar despota Stefana 5, Novi Sad 21000

(Google map link: <https://maps.app.goo.gl/DkBgdNu6qxpqykU99>).

Vespa Village and on-site registration will open on Thursday, June 12, 2025, at 10:00 AM.

Paragraph 2: Eligibility

Participants must be registered members of a local Vespa Club that is affiliated with a National Vespa Club, which is a member of the Vespa Club Europa or Vespa World Club.

From December 1st, 2024, participants can register online through VCE Website

The Presidents of National Vespa Clubs must confirm the list of participating Vespa Clubs in their country.

Only after this validation will the Organizing Committee confirm participation.

At this stage, registration will only secure a place at the event.

Additional services, such as tours and activities, will be available for booking from March 1st to May 1st, 2025.

The registration fee is non-refundable, and all tickets are personal.

Identity verification (ID, passport, or driver's license) will be required upon arrival at the Welcome/Registration area.

Paragraph 3: Participation Fee

There are only full registration tickets and daily tickets available. Lite tickets will **not** be available.

The registration fee is €80 (eighty euros) per participant, which includes VAT.

2,000 full tickets will be available, with the option to expand after registration opens.

Full payment for the registration fee is required by the end of registration, and cancellation is no longer possible once payment is made. For all online payments the sender will bear the bank and transaction fees.

However, only name changes are allowed if the replacement is a member of the same Vespa Club.

Such changes must be requested via email from the Vespa Club President before May 1st, 2025.

Daily tickets will be available for purchase at the event box office at the Vespa village for €30 per person, per day.

Children/youth under 14 years old can enter the Vespa village for free. For those 14 and older, a daily or full ticket must be purchased.

The full registration fee includes the following:

× Access to the official event program via QR code or app

× Event official bag, T-shirt of event, official metal badge, PVC banner, official patch, sticker, program and gadgets provided by sponsors

(Note: all items for full participants of EVW2025 are in limited editions and can't be bought at the event official shop.)

× Access to the Vespa Village and all activities within

× Secure Vespa parking during Vespa Village operating hours and 24 hours security

× Complimentary box lunch for the Saturday Vespa parade (main dish, drink, sweets)

× Eligibility for the Elegance Contest (Concorso di Eleganza)

× Free participation in the Gymkhana event

(applications for Gymkhana will be open on February 1st for 4 representatives from each member countries.)

× Opportunity to join officially organized rides on Thursday and Friday by registering on the event website

Paragraph 4: Currency and Payments

The official currency in Serbia is the Serbian Dinar (RSD). Money can be exchanged at any registered exchange office, and cash payments in euros or any other foreign currency is not possible.

The current exchange rate is approximately 1€ = 118 RSD.

Debit and credit cards are accepted, but we recommend checking with your bank regarding any fees and conversion rates.



Paragraph 5: Insurance

Participants are responsible for securing their own travel and vehicle insurance. We recommend that each participant checks with local insurance provider to ensure coverage for activities in Serbia, including any necessary health, accident, and vehicle insurance, before making registration payment.

Paragraph 6: Additional Regulations

In addition to the rules outlined here, the international event guidelines of the Vespa Club Europa and Vespa World Club will apply. The organizers are not liable for any risks or damages to participants, who will bear full responsibility. Participants are liable for any claims from themselves or third parties arising from their actions. Serbian law governs all aspects of the event. For safety and health reasons, external food and drinks are prohibited within Vespa Village.

Paragraph 7: Event Changes

The organizer reserves the right to alter the event program without prior notice.

Paragraph 8: Accommodation

Each participant is responsible for arranging their own accommodation.

Paragraph 9: Camp

A private camp with tents will be available exclusively for EVW 2025 participants, located 1 minute walking distance from the Vespa Village. The camp will be fully equipped with secured showers and toilets. Details about camp prices will be published until 1st of March 2024 after which the camp plots will be available for reservation. Additionally, a private Auto Camp for event participants will be set up near the Vespa Village, offering secured showers and toilets. Details about auto camp prices will be published until 1st of March 2024 after which the auto camp plots will be available for reservation.

Paragraph 10: Parking for Car/Trailers

Long-term parking will be available from Wednesday, June 11, 2025, at a specially designated parking area. This parking will be valid until Sunday, June 15, 2025, with the possibility of leaving the parking area only once. Details about prices will be published until 1st of March 2024 after which the plots will be available for reservation. If daily parking is needed during the event. Daily parking is charged by the city according to its current rates. Please note that there will be no parking available for trucks or buses.

Paragraph 11: Expulsion

Participants who pose a safety risk to others, damage property, or harm the event's reputation may be excluded from the event without compensation and held accountable for damages. Political or religious symbols or any other potentially controversial items are prohibited. If credentials (personal or vehicle) are lost or damaged, access may be denied. Participants who submit false registration information or violate the event's rules will be excluded without reimbursement. The decisions of the organizers are final. The Vespa Club Serbia reserves the right to enforce decisions for this and future international events. If part of the event has a limited number of attendees, registered participants will have priority. Each Vespa Club president is responsible for verifying that only legitimate club members are registered to ensure a positive event atmosphere and avoid fraudulent entries. The organizers reserve the right to reject any participant.

Paragraph 13: Liability

Only original, insured vehicles are allowed at the event. Participants ride and compete at their own risk. The organizer is not responsible for any personal injuries, property damage, or financial losses before, during, or after the event. By registering, participants agree to the general rules, including these terms, and waive any liability claims against the Vespa Club Serbia and the Vespa Club Europa. Participants must comply with Serbian law, including wearing helmets, protective gear, respecting speed limits, and avoiding alcohol or drug use while driving.



Paragraph 14: Acceptance of Rules

By registering, participants accept the event's terms and rules, including those outlined in this document. They also consent to the collection, storage, and analysis of their personal data for registration, organizational, and statistical purposes by the event organizers. This includes data collection for post-event verification. Personal data will not be shared with any third parties beyond what is necessary for the event and will be protected from unauthorized access. After the event, the data will be deleted.

Paragraph 15: Surveillance

The organizer reserves the right to use CCTV surveillance at the event venue and parking areas.

Paragraph 16: Alcohol, Drugs, and Weapons

The organizer reserves the right to deny entry or remove from the event any individual who:

- ×Is suspected of carrying illegal weapons, drugs, or items that could threaten event security
- ×Exhibits behavior suggesting involvement in illegal activities
- ×Is found with illegal substances or weapons
- ×Has caused public order problems at other events
- ×Is under the influence of alcohol or drugs, whether legal or illegal.
